

**FIELD TRIP RELEASE, WAIVER OF LIABILITY, & HOLD HARMLESS FORM: Terms and Conditions**

**FIELD TRIP RELEASE, WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT:** I am a student or a parent of a student that participates in GRACE Transition Education Services that will be participating in an activity or field trip offered by GRACE. My attendance in this activity or field trip is voluntary. If transportation is to be provided by GRACE, I give my permission to be transported by GRACE trainers or the charter company they hired. I represent and acknowledge by my signature below that I am eighteen years of age or older or the parent or legal guardian of a student receiving services through GRACE. I and am fully competent to sign this Agreement. I acknowledge that I am signing this Release, Waiver of Liability and Hold Harmless Agreement on my behalf and I agree to be bound by the terms of this Release, Waiver of Liability and Hold Harmless Agreement.

**Assumption of Risk:** I acknowledge that the mode of transportation and nature of the field trip/activity may expose me to hazards or risks that may result in my illness, personal injury or death and I understand, and I accept all risk to my health or that of my child that may result. I recognize and acknowledge that certain risks of harm are or may be inherent in the various activities contemplated herein and that the GRACE TES cannot control all of these risks. I acknowledge there may be physically strenuous activities and certify by my signature that I or my child is physically fit and able to participate. I agree that while participating in the field trip or activity, I will abide by the guidelines set forth in the GRACE TES and agree to adhere to all applicable rules, regulations, and laws while participating in the field trip or activity. I understand that GRACE TES is not responsible for any medical expenses associated with any property or personal injury I may sustain.

**Release:** In consideration of GRACE TES providing the opportunity for and permitting me to participate in the field trip or activity identified above and in transporting me (if that is the case), I release GRACE TES and its owner, employees, and representatives from any and all liability to me or my child, my personal representatives, estate, heirs, and assigns for any and all claims, demands and causes of action for any and all loss of personal property, illness or injury to me or my child, including my death, arising out of, resulting from, caused by, occurring during or in any way connected with the field trip/activity, including injuries caused by negligence of GRACE TES and/or its owner, employees, and representatives, or any other participant in the field trip or activity that may be sustained by me or my child while participating in such field trip/activity, or while on premises owned or leased by GRACE TES.

**Personal Insurance:** I understand that GRACE TES does not and will not provide medical insurance for me. I am urged by GRACE TES, to maintain adequate personal health and accident insurance to cover any personal injury to myself or my child which may be sustained while participating in this field trip or activity.

**No alcohol consumption:** I pledge that I will not possess, use, consume, or distribute any alcoholic beverages or illicit drugs at any time while participating in the field trip or activity.

**Indemnity, Hold Harmless, and Waiver:** I agree to indemnify and hold harmless, waive and covenant not to sue GRACE TES, owner, employees, and representatives from liability for the injury or death of any person(s) and damage to property that may result from my or my child's negligent or intentional act or omission while participating in the described field trip or activity. It is my express intent that this Covenant Not to Sue and Agreement to Hold Harmless shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representatives, if I am deceased, and shall be governed by the laws of the State of Texas.

**I HAVE CAREFULLY READ THIS AGREEMENT AND UNDERSTAND THAT IT IS A RELEASE, WAIVER AND HOLD HARMLESS OF LIABILITY OF ALL CLAIMS AND CAUSES OF ACTION FOR ANY INJURY OR DEATH TO MYSELF OR MY CHILD THAT OCCURS WHILE PARTICIPATING IN ANY FIELD TRIP OR ACTIVITY AND IT OBLIGATES ME TO INDEMNIFY THE PARTIES NAMED FOR ANY LIABILITY FOR INJURY OR DEATH OF ANY PERSON AND DAMAGE TO PROPERTY CAUSED BY MY OR MY CHILD'S NEGLIGENT OR INTENTIONAL ACT OR OMISSION.**
